



# Nuckolls County Board Minutes



## **FEBRUARY 23, 2015 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS**

The Nuckolls County Board of Commissioners met Monday, February 23, 2015 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of February 17, 2015. Christensen, Zikmund and Corman present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Corman announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 9:00 a.m. **A motion was made by Chairman Corman to approve the Agenda and the February 17, 2015 minutes. Seconded by Zikmund. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.**

Gary Warren, Highway Superintendent and Cindy Buescher, Executive Secretary met with the Board to give the weekly update on the road department. They were accompanied by Frank Robinson from Murphy Tractor & Equipment Co. Their discussion included; mechanical repairs, blading roads, hauling rock, and the start of a tree project over by Ruskin. Gary expressed his concern to the board regarding LB609. He feels strongly opposed to the bill and requests the Commissioners to study the Bill and express an opinion to Senator Kuehn. Cindy reminded the board that Nirma was holding a safety meeting at the Road Department Tuesday February 24, 2015 covering First Aide and Slips, Trips & Falls. Gary introduced Frank Robinson who answered various questions from the board about heavy equipment.

Sheriff Baker shared with the board that he had been gathering information and pricing for housing prisoners. Webster County is raising their daily rate from \$45 to \$50 and Republic is at \$30.

**A motion was made by Corman to accept 2014 Community Action Partnership Annual Report. Seconded by Christensen. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.**

**A motion was made by Christensen to approve an Application for Special Designated Liquor License for Meyer Vineyards, Inc. dba Superior Estates Winery for March 14, 2015 12:00 p.m. till Midnight. Seconded by Zikmund. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.**

Chairman Corman recessed at 10:30 a.m. for Board of Equalization.  
Chairman Corman reconvened at 10:32 a.m. in regular session.

The board made the final decision Debbie Klein would clean the Road Department offices and light landscaping in addition to her custodial job.
