NOVEMBER 2, 2015 PROCEEDINGS OF THE NUCKOLLS COUNTY BOARD OF COMMISSIONERS

The Nuckolls County Board of Commissioners met Monday, November 2, 2015 in the Board Meeting Room at the Courthouse, Nelson, Nebraska, per recess of October 29, 2015. Christensen, Zikmund and Corman present for the meeting. The agenda of said meeting was remitted to board members in advance of the meeting and is posted in the County Clerk's office and on the County Website. Chairman Corman announced the 'Open Meetings Act Law' as posted in the Commissioners Board Meeting Room and handouts are available.

The board reconvened at 9:00 a.m. A motion was made by Zikmund to approve the Agenda and the October 29, 2015 minutes. Seconded by Christensen. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

The Board of Commissioners and Elected Officials gathered in the courtroom to see Sara Bockstadter receive her Oath of Office from Diane Wehrman.

Clerk Miller requested an Executive Session concerning Pending Litigations. **A motion was made by Corman to enter Executive Session concerning Pending Litigations at 9:08 a.m. with the board members, Bockstadter and Miller. Seconded by Christensen. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried. A motion was made by Corman to return to regular meeting at 9:17 a.m. Seconded by Zikmund. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.**

Gary Warren, Highway Superintendent and Cindy Buescher, Executive Secretary, and Jeff Wagner of Mainelli Wagner & Associates met with the Board to give the weekly update on the road department. Their discussion included; members of the road department assisting with courthouse maintenance, stocking gravel in the shop yard, servicing machinery, Bridge #C006503110 has new wood deck, the dust from Road AB by Aurora Coop has become a visibility concern. Wagner suggested when accepting a bid for Project # 662 & # 587 to ensure that the culverts are NEMA approved.

Sheriff Baker gave the board the bat removal bid of \$8,790.00 for the Sheriff Department building. The board asked him to get one more opinion. Baker also explained that he has equipment and firearms on his inventory that he would like to remove to sell/exchange for firearms that can be used by the department. The discussion of the Law Contract between the City of Nelson and Nuckolls County was tabled for a later date.

A motion was made by Zikmund to Accept the Monthly Board Reports as submitted from County Treasurer, County Sheriff, County Court, Clerk of the District Court, and County Clerk. Seconded by Christensen. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.

Vicki Ensign presented the Distress Warrant name listing to the board.

Gary Warren & Cindy Buescher were present for a Bid Letting for Culverts. Three bids were submitted for "Nuckolls County 2015 Culverts". Midwest Service & Sales out of Schuyler for \$40,032.08. Contech out of Lincoln, Nebraska for \$33,752.12. Ace/Eaton Metals out of Kearney Nebraska for \$37,574.00. **A motion was made by Christensen to accept proposed bids totaling \$33,752.12 from Contech out of Lincoln, Nebraska provided the culverts pass NEMA standards. Seconded by Corman. Corman, Zikmund and Christensen all voted aye, 0 voted nay. Motion carried.**
